

Lucky Charmer VGD Hot Seats Monday, March 17, 2025 | 3pm-11pm

How to Gain Entry:

 To gain entry, participants must be 18 years of age or older and have their Muckleshoot Bingo Players Club card properly inserted and be seated at an operational VGD machine at Muckleshoot Bingo during the designated time frame: Monday, March 17, 2025, from 3pm - 11 pm.

Entry Exclusions: Muckleshoot Bingo (MIB) Employees are NOT eligible to win a hot seat prize.

How to Be Selected:

- 1. At the top of each hour, Muckleshoot Bingo will randomly select one winner using the player tracking system's random player selection/hot seat tool, which will include the winning name and the corresponding machine location.
- 2. Once the winner's name and machine location has been drawn, a VGD staff member will physically go to the machine location and verify the Players Club card inserted into the machine matches the person sitting at the location using that person's valid ID.
- 3. Once verification of the winner has been confirmed, the winning patron must go to the Players Club within 5 minutes of being verified to claim their prize (see Pay Tables for prize amounts). If the winning patron does not report to the Players Club within 5 minutes, another winner will be selected.
- 4. Participant <u>must</u> be present at the machine location drawn to win. If winning participant is not present and verified at the machine, another winning participant will be selected.
- 5. Participants must have a valid ID and Players Club card to claim their prize.
- 6. After I.D. is verified, Participant will pick a Lucky Charm from the Lucky Charmer Prize Board. The description on the reverse side will be the prize the Participant wins.
- 7. Once a Lucky Charm is selected from the prize board, that particular Lucky Charm and prize is out of play for the remainder of the promotion.
- 8. Patrons may win multiple times during this promotion.
- 9. Patrons must have a P.I.N. on their Players Club account in order to redeem free play.

General Rules:

- 1. The Muckleshoot Indian Tribe, any other contest sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use or enjoyment of prize(s), or damages or losses related to the contest.
- 2. The Tribe reserves the right to postpone, suspend, or terminate the promotion or amend the rules at any time without notice to participants.
- 3. By entering or participating in the promotion, participants grant Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likeness, or voice for promotional purposes without further compensation or permission.
- 4. Prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes unless expressly stated in the contest rules is not permitted, provided that, in the event that the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
- 5. Winners of promotional contests will be required to present valid photo identification acceptable to the Tribe, social security number, and complete an IRS Form W-9 and a winner release form before a promotional contest prize will be awarded. Failure to provide required identification and complete required IRS Form W-9 and a winner release may result in forfeiture of promotional contest prizes.
- 6. Participants acknowledge that Prizes may be subject to tax withholding under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS and such winners will receive and IRS Form 1099.
- 7. For promotional contests that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino or Bingo to participate on their behalf.
- 8. Participants are responsible for hearing contest announcements and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to contest announcements. In promotional contests involving a drawing, in case of public address system failure the drawing may continue and in such event the selected participant's name will be announced without amplification at the drawing location.
- 9. The Tribe is not responsible for lost or stolen entries, or coupons, computer malfunctions or other incidents resulting in loss of entries.
- 10. The Tribe is not responsible for inability to enter a drawing due to long lines or other causes.
- 11. Muckleshoot Bingo (MIB) Employees who are eligible to play bingo or VGD machines as outlined in the personnel policies are eligible to play during the promotional timeframe; however, MIB Employees are NOT eligible to participate and win in VGD tournaments, drawings of any kind, giveaways, Hot Seat promotions, Free Play promotions, and select discount and coupon offers. - 12. Entries are not transferable.
- 13. Violation of contest rules may result in disqualification.
- 14. Muckleshoot Bingo house rules apply.
- 15. Any guest dissatisfied with a decision/ruling in this promotion may, within thirty (30) days of the disputed decision/ruling, submit their complaint in the form of a written petition for relief to the Muckleshoot Gaming Commission.
