# **How to Gain Entry:**

- 3. Participants who have bought into the session are eligible to be (1) of (3) hot seat winners for the prizes listed in the pay table below.
- 4. Participants may only be selected to win one (1) Hot Seat prize per person, per session.

<u>Entry Exclusions:</u> Muckleshoot Bingo (MIB) employees are allowed to play bingo during the promotion, but they are NOT allowed to win a Hot Seat prize.
