



### **Hit a Homer: Red Cedar Mariners Ticket Drawings**

**Earn Unlimited Entries:** 2–10 pm every Sunday, Monday, and Tuesday, February 22 – March 17, 2026

**Grand Prize Drawings:** Thursday, March 19, 2026, at 6:30 pm

#### **How to Gain Entry:**

1. Participants must be at least 18 years of age to participate and have a valid/working email address and phone number.
2. Participants will earn one (1) entry ticket for every \$15 spent on food at the Red Cedar Deli at Muckleshoot Bingo during the promotional period, from 2:00 PM to 10:00 PM every Sunday, Monday, and Tuesday, February 22–March 17, 2026.
3. Entries are awarded based on total food spend in \$15 increments. For example, a \$30 food purchase will earn two (2) entry tickets; a \$45 purchase will earn three (3) entry tickets.
4. Entries earned through the Twin Rivers Hit a Homer promotion prior to its discontinuation on February 10 at 4:30 pm remain valid and will be carried over to this promotion. All such entries already deposited into the drawing drum will remain in the drum and will be included in the drawing for this promotion.
5. Participants may receive one (1) free entry total during the promotional period by meeting the requirements of Rule #1 and visiting the Players Club on one of the following dates: Wednesday, February 25; March 4; March 11; or March 18, between 1 pm and 3 pm. Participants must present their Players Club card and valid ID. Multiple free entries are not allowed.
6. Participants can directly deposit their entry ticket into the designated ticket drawing bin at Red Cedar immediately or retain and save their entry ticket(s) until the drawing date, Thursday, March 19<sup>th</sup>, 2026 (see section “How to Play/Win” Rule #1 for complete details on how to enter the grand prize drawings).
7. Lost or damaged entry tickets will not be replaced. No duplicate or copied entry tickets will be accepted.
8. Participants may earn unlimited entries.

**Exclusions:** *Muckleshoot Bingo Employees are NOT eligible to participate in this promotion or win a prize drawing and must not enter. If an employee should be drawn as a prize winner, their entry will be voided and another winning entry will be selected.*

#### **How to Play/Win:**

1. On Thursday, March 19<sup>th</sup>, 2026, before 6:29 pm, participants must deposit their retained, completed entry tickets into the designated ticket drawing bin at Red Cedar.
2. Participants must clearly print their first and last name, email address, and phone number on every ticket they enter into the designated ticket drawing bin. If the name is unreadable or required fields are left uncompleted, MIB will draw another winning ticket.
3. At 6:30 pm on Thursday, March 19<sup>th</sup>, Muckleshoot Bingo will randomly draw two (2) entry tickets from the designated ticket drawing bin located at Red Cedar. The first person to be drawn and verified will get to choose the prize of their choice. The second name drawn and verified will win the remaining prize.
4. The winning participant’s name will be verified by another present MIB employee. Once the name has been verified, it will be announced over the in-house PA system.
5. The winning participant must be present to win and must claim their prize at Red Cedar within 5

minutes of their name being called. If the winning participant does not report to Red Cedar within 5 minutes, another winning participant will be drawn.

6. Participants must have a valid ID and email address to claim their prize.
7. Once the winning participant has been verified, the participant's winning entry ticket will be removed from the clear ticket drawing bin.
8. The winning participants must complete an electronic ticket transfer for their Mariners Tickets by Monday, March 23, at 5pm.
9. Participants may only win one (1) prize in the drawing.

**Pay Table:**

**Prize #1:** Two (2) Diamond Club Tickets to see the Mariners vs Cleveland Guardians, on Friday, March 27<sup>th</sup> at 6:40 pm, plus a Parking Pass.

**Prize #2:** Two (2) Diamond Club Tickets to see the Mariners vs New York Yankees, on Wednesday, April 1<sup>st</sup> at 1:10 pm, plus a Parking Pass.

**TOTAL: Four (4) Mariners Diamond Club Tickets = \$1,010.50/pair or \$ 2,021 total prize pool**

**General Rules:**

1. All participants must show their Muckleshoot Bingo Players Club card and valid photo identification to be verified as a prize winner.
2. The Muckleshoot Indian Tribe (Tribe), any other contest sponsor, and their affiliated entities and their respective officers and employees shall be released and discharged from any and all claims, losses, injuries, demands, or actions which arise out of or are in any way related to the prize(s), the receipt, use or enjoyment of prize(s), or damages or losses related to the contest.
3. The Tribe reserves the right to postpone, suspend, or terminate the promotion or amend the rules at any time without notice to participants.
4. By entering or participating in the promotion, participants grant Muckleshoot Indian Tribe and its affiliated entities the right to use their names, likenesses, or voices for promotional purposes without further compensation or permission.
5. Barred and suspended patrons are not allowed to win any promotional prize and will automatically forfeit any prize.
6. Entries and prizes may not be traded or transferred. Substitution of cash, or equivalent for noncash prizes - unless expressly stated in the contest rules - is not permitted; however, the Tribe at its sole discretion reserves the right to substitute cash in the event that a noncash prize becomes unavailable. In accepting a prize, the winner accepts the prize "as is" with no warranties.
7. Players who win free play, non-cash prizes, or cash prizes under \$100 will not be required to provide a Social Security card or complete an IRS Form W-9. For promotional contest prizes of \$100 or more, players must present valid government-issued photo identification and either provide a copy of their Social Security card or complete an IRS Form W-9. Failure to provide the required documentation may result in forfeiture of the prize. Muckleshoot Indian Bingo may also request the player to complete a winner release form.
8. Participants acknowledge that prizes may be subject to tax withholding requirements under applicable federal regulations and that payouts may be reduced due to withholding requirements. Winners agree to pay all expenses, taxes, and fees not included in the prize. The Tribe will report winnings in excess of \$600 in cash or fair market value during a calendar year to the IRS, and such winners will receive an IRS Form 1099.
9. For promotional contests that require physical participation, selected participants who are physically unable to participate may designate a person other than an employee of Muckleshoot Casino or Bingo to

participate on their behalf.

10. Participants are responsible for hearing contest announcements, and the Tribe shall not be responsible in any manner for the failure of a participant to hear or respond to contest announcements. In promotional contests involving a drawing, in the event of a public address system failure, the drawing may continue. In such an event, the selected participant's name will be announced without amplification at the drawing location.
11. The Tribe is not responsible for lost or stolen entries, coupons, computer malfunctions, or other incidents that result in the loss of entries or prizes.
12. The Tribe is not responsible for the inability to enter a drawing due to long lines or other causes.

Muckleshoot Bingo (MIB) Employees who are eligible to play bingo or VGD machines as outlined in the personnel policies are eligible to play during the promotional timeframe; however, MIB Employees are NOT eligible to win VGD tournaments, drawings of any kind, giveaways, Hot Seat promotions, Free Play promotions, and select discount and coupon offers.
